President's Corner, Dave Pulver, KG4CZV

On July 19, 2007, the Daily Reflector in Greenville published an article announcing that Greenville Utilities Commission was considering getting into the internet business through the introduction of BPL in the Pitt County area.

This article caused immediate concern in the amateur radio community as bad BPL stories throughout the country have been told by numerous people. Discussions about how BARC should respond were had, and it was determined that before taking any formal action, we needed to find out what Greenville Utilities Commission intentions really were. After all, news stories don't necessarily tell the whole story.

Several decisions were initially made. First, the August GUC monthly meeting would be attended to see if the issue was discussed. If so, what was being considered? Second, consult informally with people within GUC to determine if the issue is being taken seriously by GUC. Third, bring in some experienced BPL vet-

Item 1: I attended the August GUC monthly meeting. BPL was not on the agenda, nor was it discussed. Included in the 200+ pages handed out before the meeting was the minutes from the July meeting. Here is what the minutes had to say about the BPL discussion in July:

“Presentation-Broadband Market Update (Agenda Item 7)

Earlier this year, the City of Wilson announced plans to unveil a new project that would bring broadband services to Wilson city residents through a fiber-to-the-premises project. As a result, several Board members had questions related to this project and the general status of the broadband market, including both existing and new technologies.

GUC contracted with a firm named Palmetto Engineering and Consulting to conduct a general market and technology update. George Wyatt, a Palmetto representative, made a presentation that addressed existing, emerging and potential technologies and changing customer demands.

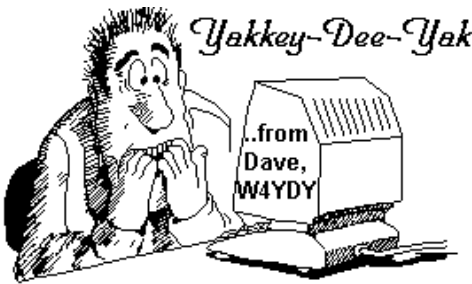
Former BARC members marry

FCC issues two citations in longstanding power line noise case

Mr. Elks (GUC General Manager) reported that staff is evaluating the technology and would like some input at a later date from the Board on the future direction of such a project."

Item 2: Several informal contacts have been made within GUC. Reports back seem to indicate that GUC is not serious about moving forward with BPL. Indications are that they believe there are enough internet providers in the area and such a venture would not be cost efficient.

Item 3: The last time BPL was the program for a club meeting was in January 2004. At the October BARC meeting, Tom Brown, N4TAB and Frank Lynch, W4FWL will be traveling down from Raleigh to talk to the club about the potential impact on Pitt County of BPL. In addition, they will also discuss what has changed in the past three and a half years since the subject was last talked about.

In summary, BPL is something that should not impact Pitt County anywhere in the near future. We are fortunate to have some resources close enough to us to learn from that are willing to share their knowledge and experiences with us. I hope there will be a good turnout for them in October, so we can all benefit from their program.

to resolve the interference until your distribution system is in compliance."

Each Lubbock utility was warned that "[v]iolations of the Act or the Commission's Rules may subject the violator to substantial monetary forfeitures, seizure of equipment through *in rem* forfeiture action, and criminal sanctions, including imprisonment." *In rem* is a civil forfeiture proceeding as opposed to a criminal forfeiture proceeding.

The Federal Communications Commission's Dallas Field Office issued Citations on July 25 to two utilities in a longstanding power line noise case in Lubbock, Texas. Bryan Edwards, W5KFT, of Lubbock, first reported the interference concerning the two involved utilities, Lubbock Power & Light (LP&L) and Xcel Energy, as early as 1994. The record shows that the FCC Dallas Field Office clarified the FCC rules with regard to power line noise for LP&L as early as 1998, and issued three letters to LP&L in 2003 and 2004. Xcel Energy was first issued an FCC letter in 2004.

The Citations to the Lubbock utilities said that due to an investigation conducted by the FCC's Dallas office May 22-25, 2007, they found that both LP&L and Xcel "caused harmful interference to the reception of amateur communications to amateur licensee W5KFT in Lubbock, Texas," and that "Section 15.209 sets the general radiated emission limits for intentional radiators. The limit for the band 30 to 88 MHz is 100 microvolts per meter measured at 3 meters. The attached list of strong electrical arcing points appears to exceed the value allowed even for intentional radiators." The list, attached to each Citation, included 44 separate "strong electrical arcing points" that were found near Edwards' home.

The FCC directed both LP&L and Xcel, pursuant to the Commission's Rules, to provide documents and information within 10 days of their respective Citations. "Because the source of harmful interference is emanating from more than one power company and past attempts have not resolved the problem, you must submit a written plan describing the planned resolution of this case," including LP&L's coordination with Xcel Energy and Xcel's coordination with LP&L, according to the Citations. Also, each company is "directed to provide a report every sixty (60) days, of work completed

I have been using an interesting computer program for the past several months having to do with propagation. It is VOAProp, a free propagation prediction program based on VOACAP. The output charts are in an easy-to-use and easy-to-understand format, plus there are excellent graphics. It is updated several times a day when you run the program with Internet connection. It draws a world map and when you select a band from 160 to 10 meters, it will draw on the map around the areas that propagation may be possible. It is a small program and very fast. It can be found at (<http://www.g4ilo.com/voaprop.html>).

A way to improve your code speed is to listen to stations on the air and make some CW contacts. A program to help in copying is CWGET. It copies CW on your computer with a single connection from your receiver. You will find that listening and seeing the results is another way to learn. Get the program at <http://www.dxsoft.com/micwget.htm>.

At the August board meeting, Tim Nelson, WA4TMN, expressed his thanks to all that had helped him with getting started in Amateur Radio. He was able to use one of the BARC transceivers and got some experience on the air before deciding on the equipment he purchased. That is an example of the help BARC will give new hams just getting started and trying to learn about equipment availability. There are a lot of choices out there and by getting some hands-on experience, it makes the decision process easier. Contact Mike Langley, KD4MTT, if you are interested in borrowing a club HF rig for a tryout. If you get your General license, you will be able to get on all of the HF bands in all modes. The Technician license is limited to 10 meters on phone it is not very good at this time of the low sunspot cycle. In a couple of years, it should much better. - W4YDY



Meet the Member, Tim Nelson, WA4TMN

Tim Nelson, WA4TMN, has come on the Amateur Radio scene with a bang, already passing two license exams, getting a vanity call with his initials, active in Field Day and getting involved on other BARC activities in just a couple of months. He has volunteered to be the Associate Editor of Ham Chatter.

He has been interested in Amateur Radio since about 12 years of age but never focused on the hobby long enough to take license exam. Professional assignments in past year regenerated his interest in ham radio because of the contribution to emergency service. He attended BARC meeting in April of this year and was impressed with the group and several members who encouraged him to get his license and become involved.

He purchased the study guide and passed the first exam in June 2007. Bernie Nobles, Ted Bertrand, Joel Muhaluk, and Murray Merner all jumped in to help him get his shack up and running with loaned equipment (club rig). He attended Field Day for two days and felt it was a great experience. He was able to meet other club members and it increased his overall excitement about a new hobby. He decided that weekend to begin studying for the General class license. He passed that exam on August 17th and it was posted on the FCC site on the 21st. He has lot of progress in a short period of time. He said, "As many have said, the sky is the limit in terms of areas of interest and equipment. It depends on how much money one wants to put into equipment and how much time one wants to devote to the hobby. The aspect that is most appealing to me is the services we provide 'when all else fails'."

Tim had some comments on his equipment. "Yaesu 897 as base station. Leaning toward an 857 for mobile. Diamond UHF/VHF antenna; Bertrand made 6M dipole; and Hustler 5-BTV multiband vertical that was "willed" to me by Joel and Bernie. Interested in a 6M beam antenna to replace the dipole and eventually a tower and triband for HF. Since the Tarheel Antenna presentation at our last club meeting, I am seriously considering the Model 75 "Stubby" for mobile. I also purchased a Yaesu FT-60 handheld that I

am delighted with. I keep it with me in the car and take it in the office each day."

He has really enjoyed the local nets on VHF and conversations on UHF. Now that he has greater privileges with the General license, he is looking forward to making DX contacts on HF. Tim is also interested in getting set up to do some data contacts and probably will give the PSK-31 a try in that regard.

Tim's club activities in his own words: "I have attended all the club meetings since April and it has been a real pleasure meeting everyone and developing relationships. I am very impressed with the special bond I feel and am seeing with active hams in our community and the region. Everyone seems eager to help new hams and several members have already demonstrated to me the importance of helping one another and serving the community in such a unique way. I have offered to serve as associate editor because I have some experience with editing and publishing a newsletter and see it as an opportunity to make a contribution to the club. I think Dave Langley does a superb job with the Ham Chatter and I look forward to learning from him and working with him." Looks like we have found our next *Ham Chatter* editor!

Tim has lived in Greenville since 1981. He grew up in Shreveport, Louisiana and he graduated from high school in 1964. He has also lived in Ohio from 1972 to 1977 (Lancaster, Columbus, Millersburg, Dover). He joined the United States Marine Corps, served four years during the period 1968-1972 and was honorably discharged as a Sergeant (E-5). During that enlistment, he served 13 months in Okinawa and was fortunate that he did not see any combat in Vietnam. He did, however, lose a lot of good friends in that conflict, as he's sure many of you did. His dad served in the USMC during WWII.

Tim has an Undergraduate degree in Criminal Justice from East Carolina University and a Masters degree in Health Law/Risk Management from Nova Southeastern University in Ft. Lauderdale, Florida.

He retired after thirty years in

state law enforcement. FCC to Lower Vanity Call Sign Fees September 17

The FCC will reduce the regulatory fee to obtain or renew an Amateur Radio vanity call sign by more than 40 percent starting September 17. In a Report & Order (R&O) released August 6, "Assessment and Collection of Regulatory Fees for Fiscal Year 2007," in MD Docket 07-81, the Commission will cut the fee from its current \$20.80 to \$11.70. This marks the lowest fee in the history of the current vanity call sign program. The FCC is authorized by the Communications Act of 1934 (as amended) to collect vanity call sign fees to recover the costs associated with that program. The vanity call sign fee has fluctuated over the 11 years of the current program -- from a low of \$12 to a high of \$50. The FCC says it anticipates some

14,700 Amateur Radio vanity call sign "payment units" or applications during the next fiscal year, collecting \$171,990 in fees from the program.

The vanity call sign regulatory fee is payable not only when applying for a new vanity call sign, but also upon renewing a vanity call sign for a new term. The first vanity call sign licenses issued under the current Amateur Radio vanity call sign program that began in 1996 came up for renewal last year.

Those holding vanity call signs issued prior to 1996 are exempt from having to pay the vanity call sign regulatory fee at renewal, however. That's because Congress did not authorize the FCC to collect regulatory fees until 1993. Such "heritage" vanity call sign holders do not appear as vanity licensees in the FCC Amateur Radio database.

Amateur Radio licensees may file for renewal only within 90 days of their license expiration date. All radio amateurs must have an FCC Registration Number (FRN) before filing any application with the Commission. Applicants can obtain an FRN by going to the ULS and clicking on the "New Users Register" link. You must supply your Social Security Number to obtain an FRN.

The ARRL VEC will process license renewals for vanity call sign holders for a modest fee. The service is available to all, although League members pay less.
